**Course Description:**

Organized under the auspices of the U.S-Asia Security Initiative at the Walter H. Shorenstein Asia-Pacific Research Center, this graduate-level seminar is being listed by Stanford University's Center for East Asian Studies and Peking University's School of International Studies. The course will be taught simultaneously on the campuses of Stanford University and Peking University and will feature a lecture series in which prominent American and Chinese scholars provide presentations that focus on key global security issues.

The course content will highlight topics relevant to current U.S.-China relations and their respective roles in Asian and global security. Proposed lecture topics include: an introduction to U.S.-China relations; finance, trade, and investment; cyber security; nonproliferation; maritime security; terrorism; and energy and the environment.

Hosted jointly but administered separately by Stanford University and Peking University, this is a 2-Unit course offered on a Credit/No Credit (C/NC) basis at Stanford University and on the Score System at Peking University. Participation is restricted to graduate students. Enrollment will be limited to 20 students at each campus.

**Class Format:**

The class will meet once a week on Wednesdays from 6:00PM to 7:30PM on the Stanford University campus (Thursdays from 9:00AM to 10:30AM on the Peking University campus) and will include a series of eight lectures on important issues in international security. Topics will be presented in English from both American and Chinese perspectives. Each week, a 30-minute lecture will be given by each of the Stanford University and Peking University scholars featured that day. The course format will consist of two 30-minute lectures followed by a 20-30 minute session for student questions and topic discussion.

Highly Immersive Classrooms (HIC) at both Stanford University and Peking University will provide the technological link between the two teaching sites that facilitates interactions between the participating faculty and students at both campuses.

**Course Technology Policy:**

In order to promote speaker and discussion candor as well as to encourage student participation and faculty-student interactions, neither audio nor video recordings will be made of or allowed in the class meetings. Laptops and tablets may be used for solely for taking notes.

**Course Requirements:**

To receive course credit, students will be required to attend and participate in all class meetings (At Stanford, there will be eight class meetings. Students who wish to withdraw from the class, must first obtain prior approval from Professor Eikenberry along with a Drop Consent Authorization Code before the course withdrawal will be recorded in Axxess. The deadline for dropping this course is 31 March 2016 (Thursday) at 5:00 PM PDT. At PKU, additional classes meetings will be scheduled at the discretion of the Lead Instructor in accordance with Peking University requirements.) Stanford University students must also submit two 5-page papers on topics selected by the Lead Instructors. Peking University students will have separate written requirements for this course.
